- 4. The programs have been granted provisional accreditation. Maturi Venkata Subba Rao Engineering College, Nadergul, Saroornagar Manadal, Rangareddy, Hyderabad-501510, Telangana should submit the Compliance Report at least six months before the expiry of validity of accreditation mentioned above to be eligible to be considered by the concerned Committee in NBA for further processing of the accreditation status. This could entail further extension of accreditation or a revisit, as deemed appropriate by NBA Committees.
- The accreditation status awarded to the programs as indicated in the above table does not imply that the 5. accreditation has been granted to Maturi Venkata Subba Rao Engineering College, Nadergul, Saroornagar Manadal, Rangareddy, Hyderabad- 501510, Telangana as a whole. As such the Institution should nowhere along with its name including on its letter head etc. write that it is accredited by NBA because it is program accreditation and not Institution accreditation.
