Memorandum of Understanding

between

Maturi Venkata Subba Rao Engineering College [MVSREC]

and

Palle Srujana

This MEMORANDUM OF UNDERSTANDING (MOU) is executed on 07th August, 2020 between Maturi Venkata Subba Rao(MVSR) Engineering College having its registered office at Nadergul, Balapur Mandal, Ranga Reddy District, Hyderabad, Telangana 501510 (hereinafter called "MVSREC" or "First Party" which expression shall where the context so admits include its successors and permitted assignees) and Palle Srujana having its office at 77, Rd Number 3, Telecom Colony, Vayupuri, Sainikpuri, Secunderabad, Telangana 500094 (hereinafter called "Palle Srujana" or "Second Party" which expression shall where the context so admits include its successors and permitted assignees). The said MOU is valid from 07th August 2020 to 06th August 2023 (3 years).

PREAMBLE

WHEREAS MVSREC is one of the earliest of the private Engineering colleges in the state, and since inception, the college has ensured excellent and exemplary standards, which has helped the

college to be one of the topmost and sought after colleges in the state. The vision of the college is to impart technical education of the highest standards, producing technically competent confident and socially responsible engineers.

WHEREAS Palle Srujana is a voluntary organization working for aiding and promoting creativity at Grassroot level in the States of Andhra Pradesh & Telangana. It pursues the mission of National Innovation Foundation –India (NIF-India) in the states of Andhra Pradesh & Telangana as part of nationwide Honeybee network. Palle Srujana Scouts across the rural parts (knowledge hubs) of Andhra Pradesh and Telangana for knowledge and innovations. Palle Srujana documents the knowledge acquired through scouting with sufficient recognition to the knowledge provider. The Grassroot innovations will be promoted and provided support for validation and reengineering. Palle Srujana also helps the innovators to get their technologies patented and take them to national and international level of recognition. The rural knowledge is disseminated horizontally, from land to land and village to village through Shodha Yatra, magazines in local language, participating in various farmers' meet etc.

Palle Srujana being a Voluntary organization, accomplishes the entire activity through pure volunteerism. The Organization involves students, elders, women, private and public institution, organizations, NGO'S and Government in the entire value chain of the grassroots innovations. The grassroots knowledge is linked to the formal system for validation, value addition, patenting, reengineering, manufacturability, marketability and business incubation etc.

Palle Srujana recognizes the need for exposure to rural grassroots innovations for the enginnering students to help them learn problem solving, inspire innovation and sensitize them towards rural context.

OBJECTIVES OF THE RURAL INTERNSHIP

- 1. To understand rural areas- their strengths, knowledge, livelihoods, harmony with nature.
- 2. To understand grassroots innovations and innovators- their genesis, their story, context, dissemination (enterprise) and impact on the society.
- 3. To assess market for these innovations, assess adequacy of technology, technical documentation, writing user and technical manuals. Understand how grassroots innovations are different in these aspects.
- 4. Soft skills like articulation, communication with villagers, team dynamics, coordination, how to work in a self-organized groups. To know the unknown and learn to articulate and share Impressions verbally and in writing.
- 5. Ability to bring village perspective to drawing board and vice versa.
- 6. Engaging with society armed with higher education.

PLAN OF ACTION

The Second Party is being invited by the First Party, to act as the authorized body to facilitate Hands-on training and/ or arrange for "internships" to technical graduate education for their Continuing Professional Development (CPD).

The obligations of both the parties are listed below: -

Rehau

A. FIRST PARTY:

The First Party shall provide students and their interest details to second party. The students undergo a Summer Internship of Rural Agriculture Work Experience (RAWE) of specified period after II-Semester and credits will be assigned by the First party.

2. Rural Agriculture Work Experience from second party helps the students primarily to understand the rural situations, status of Agricultural Technologies adopted by farmers, problems faced by them, and exploring technological solutions.

3. Fulfill all the mutually agreed requirements to make the Internship highly effective.

B. SECOND PARTY:

- 1. Conduct Rural Internship online/offline to meet the set objectives and the specified takeaways.
- 2. Provide a schedule for the internship and all logistic requirements in advance to First party.
- 3. Suggest Evaluation Criteria to First Party.
- 4. Intimate feedback on Internship to First Party.
